Minutes of the Meeting held on 8th July 1997

The Meeting was opened by the Chairman at 8.00 p.m.

PRESENT - Councillors Gapp, Mrs Gray, Mrs Hales, Mills, Playford (In the Chair) Roberts. The District Councillor and several members of the public were also present.

1. APOLOGIES

There were no apologies.

2. MINUTES

The Minutes of the meeting held on 13th May were approved. The Chairman requested that these should be signed at the next meeting as the Minute Book was unavailable at the meeting. All Councillors agreed.

3. MATTERS ARISING

There were no matters arising.

4. APPOINTMENT OF NEW COUNCILLOR

Following the resignation of Mrs Vera Ireland at the last meeting there is a vacancy on the parish council. The Statutory period for nominations ends of 10th

July. No-one has requested an election. There are two candidates for nomination (Linda Major & Vivian Richardson), and if no-one else stands by 10th July, a vote will be held for a co-option at the next meeting in September.

5. APPOINTMENT OF NEW CLERK

The Chairman extended his thanks to Mrs Sharon Crofton-Diggins who has resigned from the job of Clerk to the Council. He recorded official recognition of all her hard work for the Council. The new Clerk was introduced. Mrs Barbara Forrer will take over the post initially for three months as a trial period, during which she will be able to evaluate the job. Mrs Forrer introduced herself to parishioners who attended the meeting.

6. VILLAGE HALL REPORT

The Chairman reported that recent fund-raising events had been successful as follows:- The Fete - £630, The Jumble Sale - £180, and the Barn Dance £390. He extended thanks to everyone who had worked hard to raise these funds. The running costs of the village hall will be about £1,200.00 per annum. The extra precept from the Parish Council may not be needed for the third year.

The Village Hall Committee are concerned about the playing field equipment and there was discussion about this. The AGM will be held on Monday 21st July at the Hall commencing at 8.00 p.m.

7. DISTRICT COUNCILLOR'S REPORT

The Village Hall Committee have applied for an entertainment licence and the District Councillor is pleased to support this. With regard to telecommunication masts, the District Council is contacting the phone companies and a meeting is planned for 23rd July 1997 at Long Stratton, commencing at 1.00 p.m. This will form an integral part of the normal planning meeting, and members of the public can attend.

THE CHAIRMAN THEN ADJOURNED THE MEETING FOR COMMENTS BY MEMBERS OF THE PUBLIC. THESE ARE REPORTED AS FOLLOWS:

Concern was expressed about the SNLP - in particular the development of the village green and housing. Parishioners noted that village greens are being encouraged to be developed for the Millennium.

8. SNALP

A plan had been prepared for the meeting showing a suggested housing development and village green. Councillors and parishioners studied this. The Chairman opened the meeting to let parishioners air their views.

With regard to the Bonds Road Development, Mr Moore is appealing for a decision to allow 6 bungalows to be built. Under the SNALP this was to be 3 cottage-style dwellings. The Council has to reply to a letter by the planning inspectorate to put forward their views for 3 or 6 bungalows. There were two

Mrs B Forrer was proposed as the Responsible Financial Officer by The Chairman and seconded by Councillor Mrs Hales.

14. The date of the next meeting was set for Tuesday 16th September.

It was noted that the Recycling Centre may be installed at the north end of the Car Park. Residents who may be affected will be leafleted.

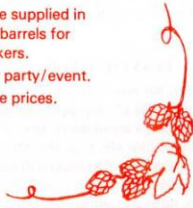
